The purpose of this memorandum is to notify all aircraft certification certification offices that we have revised FAA Form 8110-1, Type Inspection Authorization (TIA), currently available in Order 8110.4C, *Type Certification*. This applies to all field offices responsible for issuing Type Certificates (TCs) and those field offices responsible for overseeing Organization Designation Authorization (ODA) holders authorized to issue TIAs.

The format of this form consists of making it a fillable form and making it Section 508 compliant with the Americans with Disabilities Act (ADA).

There were significant content changes made to this form that were accomplished with the assistance of the manager of the AIR Flight Program Oversight Committee (FPOC). We also added the AIR Risk Management process as required by Order 4040.26, *Aircraft Certification Service Flight Test Risk Management Program*, to this revised form.

The revised FAA Form 8110-1 will be referenced in the next major revision of Order 8110.4. In the meantime, it can be obtained electronically at the FAA internal forms library at: https://employees.faa.gov/tools_resources/forms/.
