

## INSTRUCTIONS FOR PREPARATION OF FORM 8110-9, TC

- 1 - Import Certificate.** Enter "IMPORT" immediately below "Type Certificate", if issued for a product in accordance with 14 CFR 21.29. Otherwise, leave blank.
- 2 – Number.** Enter the TC number underneath "Type Certificate", as obtained from the CPN database tool or equivalent database.
- 3 – Certificate issued to.** Enter the applicant's name (must agree exactly with that shown on the application for the TC).
- 4 – Part of the Federal Aviation Regulations.** Enter the applicable Federal Aviation Regulation Part.
- 5 – Product designation.** Enter the product type designation, i.e. "Airplane Model 120". Where a second model is later added, the line would be "Airplane Models 120 and 140". If the models added become too numerous to fit into this space, an extra page may be attached to the FAA Form 8110-9. The notation should be added "See attached sheet for additional models".
- 6 – Date of application.** Enter the date of original application.
- 7 – Date of issuance.** Enter the date the TC is issued.
- 8 – Date reissued.** Enter the date the certificate is reissued when the TC is revised for the purpose of issuing it in the name of a different certificate holder or where a duplicate copy has been requested by the TC holder.
- 9 – Date amended.** Enter the date when the TC is amended.
- 10 – Signature and Title.** Obtain the signature of the manager of the accountable directorate.
- 11 - Transfer endorsement.** Reserve page 2 of the TC document (FAA Form 8110-9) as a sheet for transfer endorsements. The transfer endorsement page is to be used to notify the appropriate FAA Aircraft Certification Office of the transfer of this TC. The FAA will reissue the certificate in the name of the transferee and forward it to him.
- 12 – Continuation Sheets.** In the TC, reference the continuation sheet in a note under the applicable paragraph, for example, "See continuation sheet 3." Insert "END" below the last sentence on the continuation sheet.
